Solution **User ID Document Verification**

As part of several initiatives, we have decided to include identity verification as a mandatory requirement for distributing any content to channels.

This new feature will ensure that only legitimate creators can distribute their works, so we will continue to maintain high quality content.

To this end, we have partnered with an external provider, Veriff, a well-known player in fraud control worldwide, which allows us to provide this service in a streamlined experience.
